## AKNOWLEDGEMENTS:

**By signing below, I understand the Construction Meter is to be used for construction purposes only; It is not to be used for domestic or agricultural use. Connections to construction meters are not to be hard piped. The hose is to be disconnected and removed at the end of each work day. All air-gaps must comply with state health regulations, any variations must be pre-approved by VCMWD.**

The applicant consents to abide by the ordinances, rules, and regulations as prescribed from time to time by the Board of Directors, including all rates and charges (Article 160.3b) and provisions for installation, processing, removal and collection thereof as stated in Article 160.24, Construction Meter Service, of the Administrative Code. The District reserves the right to determine the maximum meter size for any connection. The meter applicant expressly agrees that the District is not responsible for damage occurring from excessive pressures. Anyone taking water without a permit or construction meter will be charged a penalty equal to triple the daily amount required.

**PLEASE NOTE: THE APPLICANT IS RESPONSIBLE FOR AND WILL REIMBURSE THE DISTRICT FOR ANY LOSS DUE TO DAMAGE OR THEFT OF THE CONSTRUCTION METER. CONSTRUCTION METERS ARE TO BE REMOVED OR RELOCATED BY DISTRICT PERSONNEL ONLY. FAILURE TO COMPLY WITH DISTRICT RULES AND REGULATIONS MAY RESULT IN IMMEDIATE REMOVAL OF THE METER, APPLYING THE DEPOSIT AGAINST OUTSTANDING CHARGES, AND DISQUALIFICATION FOR A SUBSEQUENT CONSTRUCTION METER RENTAL (Initial\_\_\_\_\_).**

A bill will be issued the last working day of each month for the prior month's water usage and monthly service charge. The bill is due upon receipt and becomes delinquent 20 days from the billing date. If account becomes delinquent, the construction meter will be "pulled" without any further notice from this office. Water to the construction meter is subject to reduction in delivery up to full interruption based upon water supply conditions as determined by Metropolitan and/or San Diego County Water Authority. The meter will be locked off until the water supply returns normal. (Initial\_\_\_\_\_). Completion of this application is an acknowledgement and agreement to comply with all applicable terms and conditions contained herein or referred to in this application form (Initial\_\_\_\_\_).

Applicant has received ribbon from the District (or will provide their own if applicable) to flag desired hydrant/blow off. Construction meter will not be set unless installation location has been marked (Initial\_\_\_\_\_).
